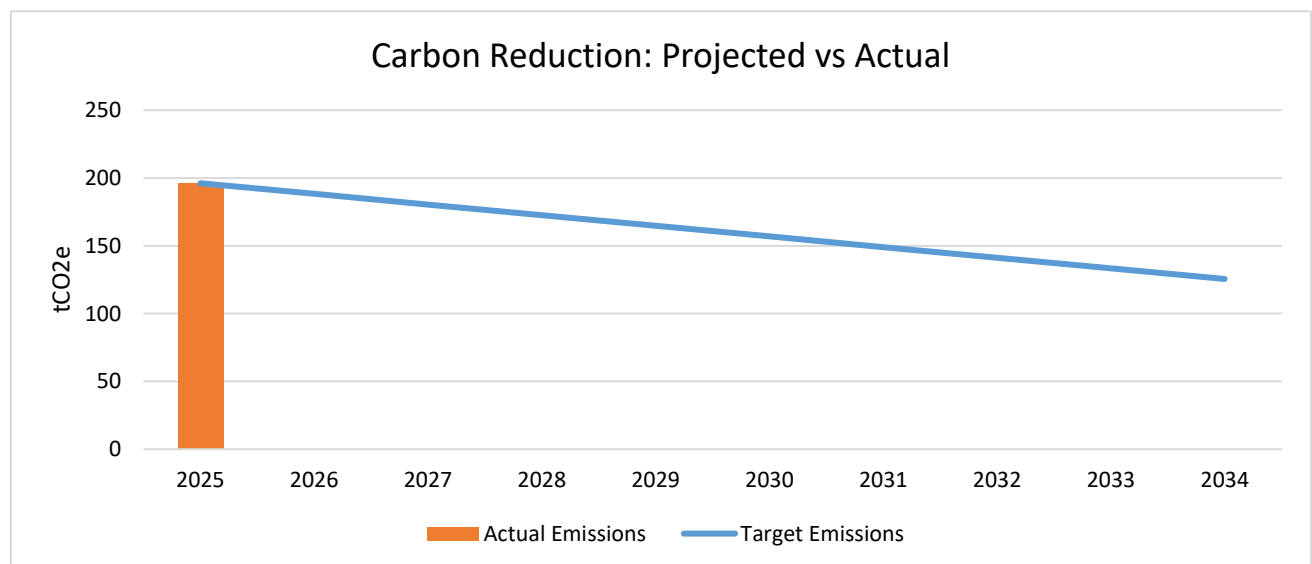

We project that carbon emissions will decrease over the next five years to 156.9 tCO₂e by 2030. This is a reduction of 20 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2025 baseline and the measures will be in effect when performing the contract.

- Implementing segregated waste bins & recycling
- Installing sleep mode on lighting (PIR)
- Getting our carbon footprint measured

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Create and publish the majority of printed materials including brochures and literature digitally instead of printing them
- Include sustainability criteria for consideration when choosing new office premises, to include bike storage, shower facilities and renewable electricity
- Record carbon footprint details of sustainable hotels used on business travel
- Engage with stakeholders to get their carbon footprint calculated and provide an emission intensity measure
- Develop employee initiatives that encourage sustainability and contribute to the wider goal of reaching Net Zero by 2050.
